- 08/17/39 Apologies for absence

- 08/17/40 Declarations of Interest  
Planning application - the Parish Council declared a non-pecuniary due to being adjacent landowners.
- 08/17/41 Minutes of the meeting held on 11<sup>th</sup> July 2017 were agreed and signed as a complete record with the following amendment:-
- Item 07/17/32** Footpath from Canada Drive to Etton Road  
The landowner could dedicate a path and they might do this if ERYC decides to continue with the Schedule 14 Application.
- 08/17/42 Planning Application  
This item was brought forward.  
Erection of dwelling on land west of 2, The Meadows.  
There was a discussion about the application and reasons for objecting to it discussed. These were read out.  
**Standing orders were suspended** and the Vice-Chair asked if there were any further comments from the members of the public present.  
A resident had concerns about the dwellings proximity to the pond and the need for some sort of safety barrier to prevent anyone falling in.  
Concern was expressed by others about enclosing the area and there was a discussion about when the Smithy was removed in the early 1970s.  
The Chairman thanked the members of the public for their comments.  
**Standing orders were re-instated.**  
**Resolved** – the Parish Council voted and unanimously and strongly recommended that the application is refused and request that, if the planning officer is recommending a different decision, it should be referred to the appropriate Committee/Sub-Committee. See attached comments to be submitted.

Schedule 14 Footpath from Canada Drive to Hudson Way

ERYC had requested supplementary evidence demonstrating the use of the field edge path since 1970 and this has been prepared and will be delivered shortly.

Affordable Housing

Mr Siddle had emailed and offered to try and identify a suitable housing association that would be prepared to do work as a risk. Resolved – Inform him that the PC are concerned that the proposal would be another development in addition to the two allocated sites on the Local Plan and would be based on a very limited response in the survey. It was felt that if there is a need then it should be met by affordable housing within these sites and mention that the site had been rejected in the past.
